

# ARCTIC CIRCLE MEMBERSHIP TERMS & CONDITIONS

Upon submitting my first payment of 25usd per member or more I agree to enrolling and becoming a member under the **No Plans Adventures LLC** program “**Arctic Circle**” and agree to the following terms and conditions:

I agree to opening an account under **No Plans Adventures LLC** and having the credit card of my choosing charged 25usd, or any greater amount of my choosing, on the 15<sup>th</sup> of every month unless I pause or cancel my membership. I agree to receiving zero compensation in the form of interest or any other alternative. I understand that I am permitted to contribute any amount greater than 25usd and can do so by emailing **No Plans Adventures LLC** at [info@noplansadventures.com](mailto:info@noplansadventures.com) stating my new desired contribution amount. I agree to having my **Arctic Circle Membership** terminated, at the full discretion of **No Plans Adventures LLC** for missing a monthly contribution or in any other way violating the **Arctic Circle Membership Terms & Conditions** and having my account refunded to me per the **Arctic Circle Cash Back Policy**. I understand that I am free to terminate my **Arctic Circle Membership** of my own accord at any time and will have my account refunded to me per the **Arctic Circle Cash Back Policy** outlined below. To cancel my **Arctic Circle Membership**, I understand that I am required to email **No Plans Adventures LLC** at [info@noplansadventures.com](mailto:info@noplansadventures.com) stating my request to cancel and be refunded per the **Arctic Circle Cash Back Policy**. I am under no obligation to provide a reason for cancellation.

**Arctic Circle Membership** entitles me to exclusive discounts on guided trips booked through **No Plans Adventures LLC** as well as other benefits and promotions exclusive to members. Discounts can be implemented or revoked at any time by **No Plans Adventures LLC**. I understand that if I choose to cancel my **Arctic Circle Membership** before embarking for my discounted trip, **No Plans Adventures LLC** is permitted to retract my **Arctic Circle** discount for said trip and I agree to pay the non-discounted trip cost. Upon booking an adventure with **No Plans Adventures LLC**, I understand my right to use all or part of my **Arctic Circle Fund** including credits towards said adventure at a rate of 100% and will have my options thoroughly explained to me by **No Plans Adventures LLC** at the time of booking. I am still eligible to receive a personalized payment plan upon booking my adventure whether or not I choose to incorporate my **Arctic Circle Fund**. I understand that I may choose to pause my **Arctic Circle Membership** at no cost after booking a trip with **No Plans Adventures LLC** for the duration of my trip payment plan. Upon submission of my final payment towards said trip, I agree to my **Arctic Circle Membership** being automatically reinstated on the 15<sup>th</sup> of that month. I agree to receiving periodic emails from **No Plans Adventures LLC** stating the total monetary amount in my **Arctic Circle Fund** as well as additional credits available for use on future bookings. I understand **No Plans Adventures LLC** is contractually bound to provide me with updated information on the contents of my **Arctic Circle Fund** any time requested by email to [info@noplansadventures.com](mailto:info@noplansadventures.com). I understand I am only permitted to receive information pertaining to my own **Arctic Circle Membership** and **No Plans Adventures LLC** is unable to share any other **Arctic Circle Member**'s information with me.

**Arctic Circle Cash Back Policy** is as follows: I am entitled to receive 90% of my most recent contribution within 5-10 business days via PayPal to the PayPal email I provide. I am entitled to receive 90% of any amount (including full amount but excluding “credits”) I choose from my total fund paid out in no more than six monthly installments via PayPal. I understand credits accrued into my account through promotions or any other method have zero cash value and will not be included in any refunds issued.
